### **HEBREW BIBLE**

Our **focus** in this course will be to view the variety of texts contained in the Hebrew Bible of ancient Israel within the historical, cultural, and religious contexts within which these texts developed. The history of the ancient Near East provides an important backdrop for the movement from polytheism to monotheism, from Israelite religion to Judaism, as well as the themes of covenant and theodicy and the ancients' understanding of the nature of the divine and its relationship with humanity. Although the Hebrew Bible continues to be a sacred text for the monotheistic traditions of Judaism, Christianity, and Islam, our goal will be to understand it from the perspective of its original authors and audiences, rather than adopting the lenses of the later history of interpretation.

Our **objectives** are: (a) to develop an academic approach to the study of religious texts, using the tools of literary study, anthropology, history, and archaeology; (b) to understand the history, culture, and worldview of ancient Israel as separate from and prior to the historical development of Judaism and Christianity; (c) to understand the variety of genres and source texts contained within the Hebrew Bible and appreciate the ways in which they operate both independently of and in combination with each other; and (d) to understand and appreciate the interaction between text and context, culture and history, in determining religious meaning.

### **Required Texts**:

- You will need a Bible. I have ordered the Jewish Publication Society's *Tanakh* (in English) for this class, but other modern Bible translations are acceptable. Modern translations include anything produced after the discovery of the Dead Sea Scrolls such as the Revised Standard and New Revised Standard Versions (RSV and NRSV), New English, Jerusalem, New International Version. Check the title page of any Bible you own to check the translation. Though poetic, the King James Version is not an accurate translation and won't work for this class.
  \*Note: good Bible translations are also available online. I recommend biblegateway.com but choose NRSV translation in the dropdown menu.
- 2. I will be uploading several articles to CULearn. These are required reading, as noted in the schedule below.
- 3. Richard E. Friedman's bestselling *Who Wrote the Bible*? Friedman offers an engaging look at how biblical scholarship works, and a very accessible introduction to how and when the Hebrew Bible was put together. This is also required reading, as noted on the schedule below (WWTB).
- 4. Stephanie Dalley's *Myths from Mesopotamia*; also required reading.
- 5. Optional (but encouraged): bibleodyssey.org great timelines, maps, and short articles on all things biblical.

#### **Evaluation:**

- 1. Bi-weekly quizzes on lecture & reading material, worth 5% each, total of 30%.
- 2. Final examination, date TBA (during finals week), worth 30%.
- 3. Exegetical paper assignment, details TBA, due beginning of class November 30th, worth 30%.
- 4. Attendance and Participation, worth 10%.

# Deferred Term Work

In some situations, students are unable to complete term work because of illness or other circumstances beyond their control, which forces them to delay submission of the work.

Students who claim illness, injury or other extraordinary circumstances beyond their control as a reason for missed term work are held responsible for immediately informing the instructor concerned and for making alternate arrangements with the instructor and **in all cases this must occur no later than three (3.0) working days after the term work was due.**

# Deferred Exams

Students who do not write/attend a final examination because of illness of other circumstances beyond their control may apply to write a deferred examination.

- 1. be made in writing to the Registrar's Office **no later than three working days after the original final examination or the due date of the takehome examination;** and
- 2. be fully supported by appropriate documentation and in cases of illness by a medical certificate dated no later than one working day after the examination or by appropriate documents in other cases. Medical documents must specify the date of the onset of the illness, the (expected) date of recovery, and the extent to which the student was/is incapacitated during the time of the examination. The University's preferred medical form can be found at the Registrar's Office forms and fees page.

The granting of a deferral also requires that the student has performed satisfactorily in the course according to the evaluation scheme established in the Course Outline, excluding the final examination for which deferral privileges are requested. Reasons for denial of a deferral may include, among other conditions, a failure to (i) achieve a minimum score in the course before the final examination; (ii) attend a minimum number of classes; (iii) successfully complete a specific task (e.g. term paper, critical report, group project, computer or other assignment); (iv) complete laboratory work; (v) successfully complete one or more midterms; or (vi) meet other reasonable conditions of successful performance.
